Data collection	Our tree-inventory data (July 2024 - ATDN20240717) are part of the Amazon Tree Diversity Network 8,9,44 , which contained 2,254 tree-inventory plots with information on species composition and abundance. Environmental attributes were extracted from gridded data. Trait data was obtained from the TRY database, published data and some unpublished data, cited in the methods section.
