Evolution of policies towards informal settlements in Pakistan

1947	No overt policy. Indirect policy of allowing squatters to occupy available public land and buildings. The government spent money providing water and sanitation for the squatters.
1952 [did not get legal cover]	Greater Karachi Plan/MRV Plan
1958 [shelved in 1964]	Greater Karachi Resettlement Plan (GKRP)
1964 - 1974	Development of 3 townships in West Karachi
1967	Karachi Master Plan
1974 - 1985	KMP through Metroville Programme
1972	Lease rights offered to Lyari citizens
1973	Katchi Abadi Improvement and Regularization Programme (KAIRP)
1978	Martial Law Order (MLO) 183 "Regularization and Development of Katchi Abadis". KMC set up Directorate of Katchi Abadis.
1980	MLO 130
1983	MLO 202 [a reconstitution of 130]
1986	Prime Minister announces that the cut-off date has been extended to the 23 rd of March 1985
1987	Katchi Abadi Act [for entire country]
1987 [KMP revitalized] Now in use	Sindh Katchi Abadi Act [created Sindh Katchi Abadi Authority]
1993 Now in use	Sindh Katchi Abadi Authority
2001	Presidential Decree directing that katchi abadi dwellers who have no alternative shelter should not be summarily evicted.

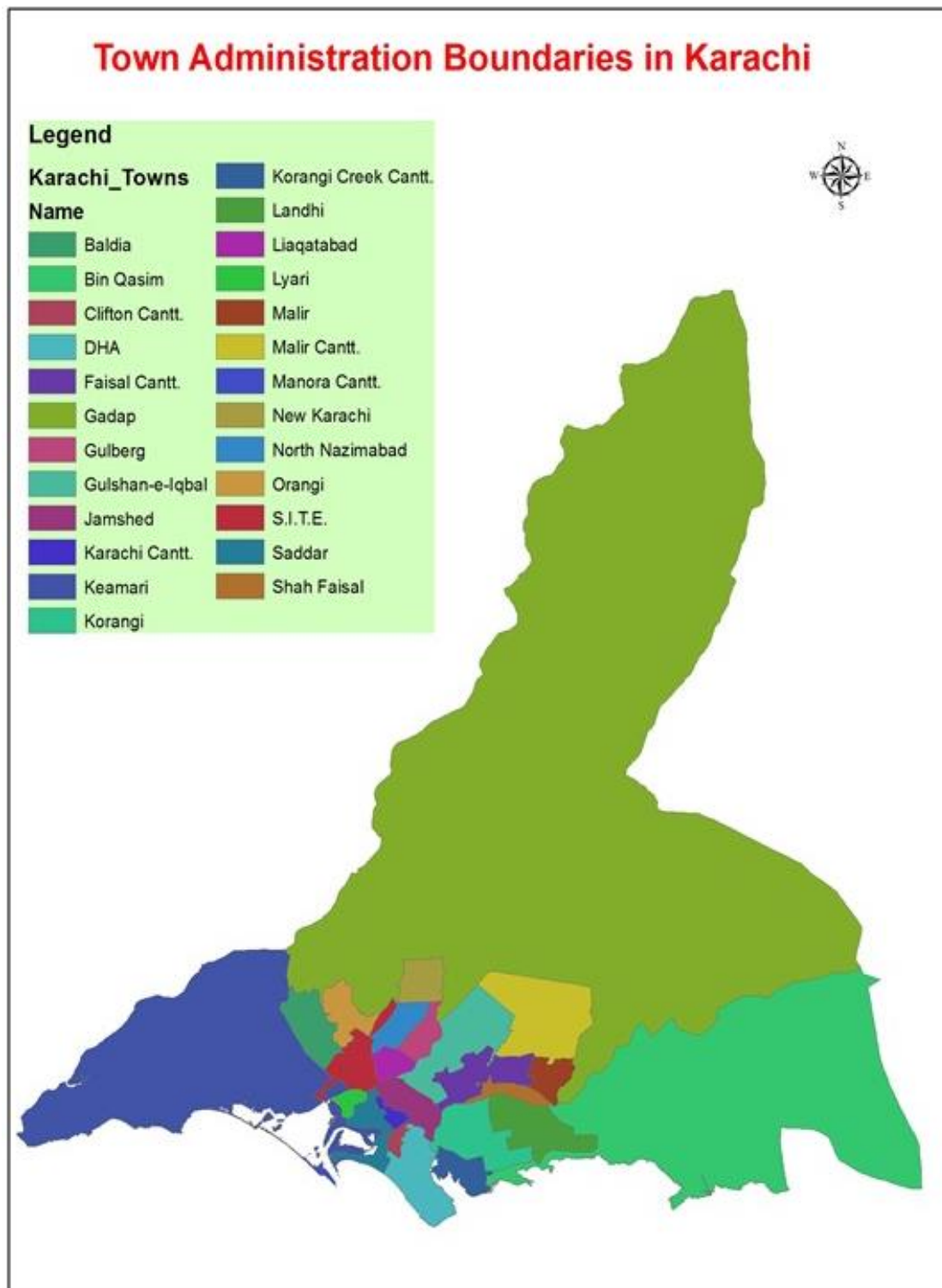
Map of the province of Sindh and the city of Karachi

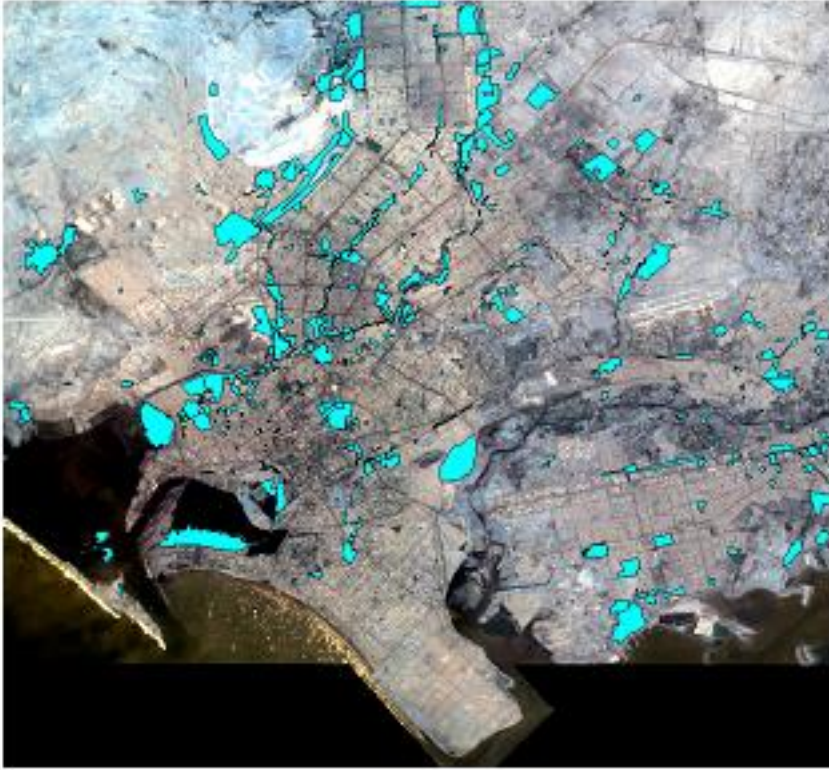
Map of administration boundaries in Karachi
