Life sciences study design

Sample size	The number of datasets was chosen to reflect realistic experimental throughput: for each biological scenario ("experiment"), we simulated 30 fields of view, which we group conceptually as three technical replicates of ten videos each. In practice, our design mirrors the data volume and variability encountered in typical live-cell single-particle tracking studies. By providing 30 independent views per scenario, we ensure robust estimates of parameters while keeping the computational load manageable; this balance between realism and statistical power underpins the sufficiency of our dataset for benchmarking analysis methods. Further details on dataset structure and rationale are given in the main text.
Data exclusions	As described in the manuscript, three experiments used in the challenge contained parameters meant to assess potential biases of the methods and although they were used for challenge ranking, they were not discussed in the article.
Replication	Our datasets are wholly synthetic—trajectory and video simulations drawn from known parameter distributions— so traditional technical replication does not apply. Instead, we capture variability by generating multiple independent realizations for each scenario. Specifically, we simulate 30 fields of view per condition.
