Data collection	The source code used for cohort definition, matching, and data analysis was created using Python (version 3.9) and standard scientific computing and machine learning libraries (scikit learn, polars, pandas, numpy, scipy). Dependencies were managed using Poetry. Data were plotted using matplotlib and seaborn in Python
Data analysis	Cumulative hazard functions for each cohort were evaluated at defined timepoints post-index date using the Nelson-Aalen estimator. Equivalence was determined via a chi-squared test ($\alpha=0.05$) between the pairs of cohorts in terms of the difference of their cumulative hazard distributions at each evaluated timepoint (58). Missing covariates were imputed using the Multiple Imputation by Chained Equations method (59)
